REQUIREMENTS FOR PROCESSING OF MALAYSIA VISA,**

The processing of visas for delegates will be handled by the Institute to ensure seamless visa issuance to members.

All delegates are to pay the sum of #30,000 to cover Visa fees and other administrative expenses to “**Account Name: Institute of Chartered Accountants of Nigeria, GTB #0000631076**”.

In addition, members are to forward receipt of payment and the following documents to the **Membership Affairs Directorate, Institute’s Secretariat, [Plot 16, Idowu Taylor Street, Victoria Island, Lagos](#)**, for onward submission to the Malaysian Embassy in Abuja:

1. Yellow/Vaccine card photocopy
2. Photocopy of data page of international passport in colour (2 copies)
3. Letter of introduction from ICAN Nigeria
4. Letter of invitation – (To be provided by ICAN Malaysia District)
5. 6 months Statement of account of applicant with a stamped covering letter from the bank(addressed to the Malaysian Embassy)
6. For first time travelers, NDLEA clearance certificate/Letter
7. International passport must have (with 6 months validity)
8. Hotel reservation (Malaysia District to provide)
9. Ticket reservation
10. Photocopies of valid visas
11. Self introductory letter(Addressed to the Malaysian Embassy)
12. Completed Visa Application Form.(To be filled with black pen)
