19TH CONFIRMATION OF FELLOWSHIP STATUS CEREMONY

The Fellowship Status of the Institute of Chartered Accountants of Nigeria (ICAN) is the highest designation a member can attain in his/her professional career as a Chartered Accountant. The Confirmation Ceremony holds once every year and **the next edition will be held on Monday, April 26, 2021 by 11:00am.**

1. ELIGIBILITY:

Members in the following categories are eligible for transfer to Fellowship in 2021:

a. **Members in Practice:** An eligible member in this category must:

- i. hold a licence to practise for 5 years issued on or before January 1, 2016, and
- ii. be in continuous practice, using the licence, on his/her own or in partnership with other accountants

b. **Members not in Practice:** An eligible member in this category must have enrolled as Associate (inducted) not less than 10 years immediately preceding the date of next Confirmation Ceremony i.e. on or before January 1, 2011.

2. FEES:

Members: **₦120,000**

NB: Fees are subject to change at the discretion of the ICAN Council

NOTE

i. All outstanding dues **MUST** be paid before applying for Fellowship.

ii. Payment and online application will close on Monday, April 12, 2021.

iii. Friends and well-wishers may place congratulatory messages/adverts in the Brochure at the cost of **₦25,000** (full page) and **₦15,000** (half page). Payment evidence and artwork must reach the Institute on or before Monday, April 12, 2021. Artwork should be sent through fellowship@ican.org.ng ONLY

iii. Payment for advert placement should be made to "The Institute of Chartered Accountants of Nigeria", GTBank A/C no: 0000631076. Kindly use different pictures for multiple adverts for one person to avoid omission.
